Higher ED Partners Meeting 1 Notes – 11/07/2022 – 10am


- David Bowman gave an introduction to the REC and the Digital Equity Study Incitive

 - Struggling on marketing

- Online students time management was a problem.
- Daniel Kerr – DACC:
 - How do we address student conversation between those who are treatment vs control? I get to do this but you don't. – We just make it known that this was a random selection process or lottery much like how the student was selected to attend the ECHS.
- Dr. Baca -UNM Taos:
 - Get Bilingual videos and materials
 - Dual Credit vs Regular High School Credit – If students enroll into a class from their ECHS, this concurrent enrollment or dual credit.
- Hank Hargis – ENMU Ruidoso:
 - The enrollment of the students in the IT pathways will be the responsibility of the administration and the counseling department at the ECHS not the Higher Education Institution.
- Concerns were raised with issues on possibly limited pathway opportunities to students. This was addressed by explaining the evaluation process and the difference between the random selection of control vs treatment.
- Questions were asked if this would be an added task or responsibility when the selection would fall on RAND and the enrollment would be the responsibility of the ECHS.
- In collaborating with your ECHS partners, what are the on-campus options for computer science and IT? Is there an eligible teacher of record that is a masters degree holder that could teach a face-to-face dual credit class during the regularly scheduled school day? How are the IT opportunities being marketed to the dual credit students at the ECHS? In addition, is there a Cyber Patriot program or a SkillUSA team at the ECHS? These activities will boost enrollment.
- How can we develop online orientations that will prepare dual credit students that are fresh out of middle school to be ready for collegiate level classes? Especially online.
